- H. City Commission to consider authorizing staff to advertise for bids on twenty four (24) Oak Creek Lake and eight (8)

Sweetwater Lake lot leases for leasehold interest in said lots. A minimum bid of \$600 plus \$600 annual lease and a \$750 transfer fee to be included with cashier's check payable to the City of Sweetwater. Successful bidder must enter into a lake lot lease agreement and abide by all terms of said lease.

- A. The Texas Parks and Wildlife Department stocked 50,809 Florida largemouth bass on 5/25/2016 in Oak Creek Lake.
- B. The City received the Distinguished Budget Presentation Award for the Fiscal Year beginning October 1, 2015 from the Government Finance Officers Association.
- C. Installation of a new Automated Utility collections Kiosk at City Hall will begin late June. This Kiosk will replace the old drive thru window. The automated window will allow customers to look up and pay their bill with cash, checks, debit and credit cards. Also, there will be a pay by phone extension to the Kiosk.
