Motion was made by Mayor Pro-Tem Peek, seconded by Commissioner Castro to authorize staff to advertise to receive sealed bids for water line replacement near the new elevated storage tank to be funded by the TWDB, with bids to be opened at the regular City Commission meeting on June 13, 2017. The motion carried unanimously.
- D. Motion was made by Commissioner May, seconded by Commissioner Lee to appoint Matt Counts to the Pioneer City County Museum Board for a (2) two-year terms. The motion carried unanimously.

E. Motion was made by Mayor Pro-Tem Peek, seconded by Commissioner May to enter into a public hearing to close one block of Mississippi Avenue, a platted but undeveloped street, from Lanham Street to Robert Lee Street. The motion carried unanimously.

Motion was made by Commissioner May, seconded by Commissioner Lee to close public hearing and enter into regular session. The motion carried unanimously.

F. Motion was made by Commissioner Lee, seconded by Commissioner Castro to enter into a public hearing to approve plat designated as the Fairfield Subdivision to the City of Sweetwater. The motion carried unanimously.

Motion was made by Mayor Pro-Tem Peek, seconded by Commissioner May to close public hearing and enter into regular session. The motion carried unanimously.

Kirk Harris, City Services Director spoke on proposed use.

Motion was made by Mayor Pro-Tem Peek, seconded by Commissioner May to approve plat designated as the Fairfield Subdivision to the City of Sweetwater. The motion carried unanimously.

G. Motion was made by Mayor Pro-Tem Peek, seconded by Commissioner Lee to approve entering into a non-exclusive solid waste disposal agreement with Republic Waste Services of Texas, Ltd. For disposal of municipal solid waste and dried sludge from the City wastewater plant at the Abilene Landfill. Kirk Harris, City Services Director spoke about the cost savings. The motion carried unanimously.

BE IT RESOLVED THAT THE GOVERNING AUTHORITY OF THE LOCAL GOVERNMENTAL **ENTITY** DOES **AUTHORIZE JIM MCKENZIE, MAYOR AND HIS SUCCESSORS TO** NEGOTIATE, ON TERMS AND CONDITIONS THAT HE MAY DEEM ADVISABLE, A CONTRACT OR CONTRACTS WITH THE TEXAS DEPARTMENT OF AGING AND DISABILITY SERVICES (DADS), AND TO EXECUTE THE CONTRACT OR CONTRACTS ON BEHALF OF THE LOCAL GOVERNMENT ENTITY, AND FURTHER WE DO HEREBY GIVE HIM THE POWER AND AUTHORITY TO DO ALL THINGS NECESSARY TO IMPLEMENT, MAINTAIN, AMEND, RENEW OR REQUEST CLOSURE OF THE CONTRACT. ALTHOUGH THE AUTHORITY OF THE SUCCESSORS IS BINDING ON THIS ENTITY, IT IS ACKNOWLEDGED THAT THIS ENTITY MUST SPECIFICALLY AUTHORIZE ANOTHER PARTY BY NAME IN A RESOLUTION DAYS OF THE CHANGE WITHIN 30 AUTHORIZATION, OR WHEN SPECIFICALLY REQUIRED BY DADS, WHICHEVER IS SOONER.

reimburse ACSC's reasonable ratemaking expenses; determining that this Resolution was passed in accordance with the requirements of the Texas Open Meetings Act; adopting a savings clause; declaring an effective date; and requiring delivery of this Resolution to the Company and the ACSC's legal counsel. The motion carried unanimously.
