The City Commission of the City of Sweetwater, Texas, will meet in regular session on Tuesday, April 8, 2014 at 9:00 a.m. in the City Commission Room of the City Hall, 200 E. 4th Street, Sweetwater, Texas.

 - A. Mayor Wortham to proclaim April as National Safe Digging Month in Sweetwater.
 - B. Mayor Gregory Wortham to proclaim Sunday, April 13, 2014 as "A Day of Prayer for Rain".
 - C. City Commission to open and consider bids on City-owned lots located at 112 and 114 Tom Green Street.
 - D. City Commission to consider appointment of Robert Pieper to the County- City Library Board to fill the expired term of

Richard Ferguson which ended December 31, 2013. New term began January 1, 2014 and expires December 31, 2016.

- E. City Commission to consider approval of investment report for the quarter ended March 31, 2014.
- F. City Commission to consider appointment of judge and alternate judge Olga Balderas and Kevin Shipp to replace Ann McCarthy and Paul McCarthy who have moved away from Sweetwater.
- G. City Commission to authorize staff to purchase a 5 or 6 yard Ford F-750 dump truck through the HGAC purchasing cooperative for \$68,795.
- H. City Commission to consider first reading of an ordinance establishing classifications and number of positions for the fire and police departments pursuant to Chapter 143 of the Texas Local Government Code; providing a severability clause; finding and determining that the meetings at which the ordinance is passed are open to the public as required by law; and providing for an effective date.
- I. City Commission consider setting date of meeting to canvass votes of the May 10, 2014 election for precincts 2 and 4. The meeting cannot be held until after the sixth day after the election.

- A. Schedule a budget workshop on 2014-2015 Budget for May 27, 2014 at the Water Treatment Plant on Hillsdale Road, time to be determined.
- B. eHT (Hibbs and Todd) engineers have completed inspections of the City-owned dams located at Lake Sweetwater, Lake Trammell and Oak Creek Lake.
- C. A table top exercise relating to the City's Dam Emergency Action Plans was conducted March 25, 2014. Representatives from eHT, City Management, Nolan County, Coke County, National Weather Service, Texas Emergency Management and TCEQ were in attendance.
- D. SNAP is sponsoring the Taste of Sweetwater to be held April 14, 2014 from 5:30 – 7:30 p.m.
- E. Early voting begins April 28 through May 6 at City Hall and the election will be Saturday, May 10, 2014 at Sweetwater Middle School.
