The City Commission of the City of Sweetwater, Texas, will meet in regular session on Tuesday, September 16, 2014 at 9:00 a.m. in the City Commission Room of the City Hall, 200 E. 4th Street, Sweetwater, Texas.

 - A. City Commission to consider second and final reading of an Ordinance Amending the Budget for Fiscal Year beginning October 1, 2013 and ending September 30, 2014.
 - B. City Commission to consider second and final reading of the Appropriations Ordinance for the 2014-2015 Budget.
 - C. City Commission to consider second and final reading of an Ordinance to adopt the 2014-2015 Budget.
 - D. City Commission to enter into a public hearing to discuss the proposed tax rate of \$.48 (48 cents) per \$100 valuation for Tax Year 2014.
 - E. City Commission to consider closing the public hearing and returning to regular session.
 - F. City Commission to consider any action from the public hearing.
 - G. City Commission to consider first reading of an Ordinance fixing and levying a tax for the year 2014 upon all City property within the corporate city limits of the City of Sweetwater, Texas. The tax rate of \$.48 (48 cents) will raise more taxes for maintenance and operations than last year's tax rate. The tax rate will effectively be raised by 4.82 percent and will raise taxes for maintenance and operations on a \$100,000 home by approximately \$0.00.

- H. City Commission to consider second and final reading of an Ordinance annexing the following described territory, to wit:

Area 1: 413.935 acres of land out of Section 36, Block 22, T & P RR. Co. Surveys, Nolan County, Texas.

Area 2: 109.830 acres of land out of Section 41, Block 21, T & P RR. Co. Surveys, Nolan County, Texas.

Area 3: 53.578 acres of land out of Section 52, Block 22, T & P RR. Co. Surveys, Nolan County, Texas.

- I. City Commission to consider second and final reading of an Ordinance amending Chapter 8 of the Code of Ordinances of the City of Sweetwater entitled "City Cemetery" by amending section 8-20 entitled benches, fencing, etc., prohibited; exception. By deleting section 8-20 (a) and (b) and substituting a new section 8-20 entitled benches, fencing, etc., prohibited.
