- 2. Commissioner Larry May gave the invocation.
- 3. Mayor Wortham led the pledge of allegiance.
- 4. Motion was made by Commissioner Peek, seconded by Mayor Pro-Tem McKenzie to approve minutes for the meeting held on February 12, 2013. The motion carried unanimously.

5. Action Items:

A. Motion was made by Commissioner May, seconded by Mayor Pro-Tem McKenzie to approve the contract with Cathrine Wilks, Certified Public Accountant, for the performance of an agreed upon procedures engagement for the mid-year report as of March 31, 2013. The motion carried unanimously.

There are numerous portions of streets and alleys closed in this area. The motion carried unanimously.

- G. Motion was made by Commissioner Peek, seconded by Mayor Pro-Tem McKenzie to close the public hearing and enter into regular session. The motion carried unanimously.
- H. Motion was made by Commissioner May, seconded by Mayor Pro-Tem McKenzie to approve the abandonment and closure of the following right -of -way: A 12.5' x 482.6' platted but undeveloped dead-end alley in Block 53, Southside Addition, located between Bowie and Henderson Streets, west to east, and Block 8 Goulds 2nd addition and west Bradford Lane, north to south. - L. Motion was made by Mayor Pro-Tem McKenzie, seconded by Commissioner Peek to authorize staff to obtain bids on 2007 or newer used 15 yd to 16 yd dump truck for landfill use. The motion carried unanimously.

The motion carried unanimously.

- M. Motion was made by Mayor Pro-Tem McKenzie, seconded by Commissioner May to authorize staff to obtain bids for the construction of a bulk water sales station at the Highland Pump Station site.
- N. Motion was made by Commissioner May, seconded by Mayor Pro-Tem McKenzie to request staff propose changes to the ordinance on "Freight and Portable Containers" to be more construction company friendly. The motion carried unanimously.
- O. City Commission discussed criteria for proposed RV Park ordinance.
- 6. City Manager's Report.
 - A. City Staff working on budget packets for the 2013-2014 budget.
 - B. City Manager reported on Sweetwater Enterprise for Economic Development (SEED) Board decision regarding City Commission Resolution requesting financial assistance for the Bradford Lane/SH 70 sewer line project. Mr. Brown advised the Commission that the SEED board had turned down the request for assistance to the City with this infrastructure project. A motion for approval of the City Commission Resolution was made by board member Jerod Peek; however, the motion died for lack of a second.
 - C. Texas Water Development Board approved a \$7.5 million loan to Bittercreek Water Supply Corporation. TWDB staff commented to the Board in open session that the loss of BCWSC revenue to the City of Sweetwater was not significant to the City.
 - D. Taste of Sweetwater will be held Monday, April 8, 2013 at the Nolan County Coliseum.
 - E. The dam inspections for Oak Creek Lake, Lake Sweetwater and Lake Trammell were completed by Enprotec, Hibbs & Todd Engineers.
 - F. The City of Sweetwater has received the Distinguished Budget Presentation Award from the Government Finance Officers Association (GFOA). This is the 29th year to receive the award.
 - G. Staff has submitted an application to Texas Water Development Board for 2014 cycle funding under the Drinking Water State Revolving Fund.
