
**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SWEETWATER, TEXAS:**


That said election was duly called; that notice of said election was given in accordance with law; and that the proposition voted on in said election was approved.
